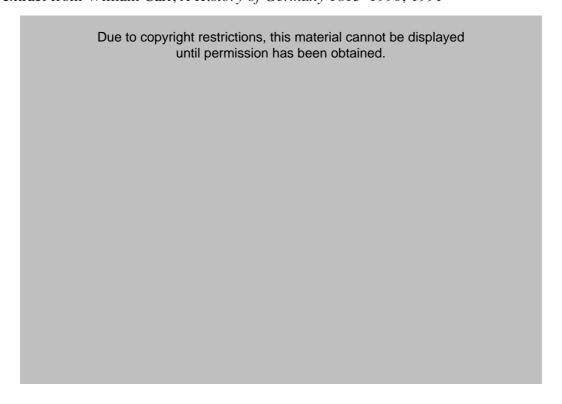

An extract from Richard Bessel, 'Political Violence and the Nazi Seizure of Power' in *Life in the Third Reich*, 1987

Nazi activists did not shrink from violence; indeed they glorified in it. Struggle, violence and war were at the centre of Nazi ideology... And when, in early 1933, the Nazis finally were able to gain control of interior ministries and police headquarters throughout Germany, storm troopers unleashed a campaign of terror. Thousands of opponents of the Nazis were rounded up and taken away to makeshift concentration camps set up in disused factory premises or barracks, and many met their deaths at the hands of tormentors behind them.
