School Bus 8 will now travel from Bathurst St & Bootles Ln via (R)Bootles Ln (L)Bona Vista St (L)Johnston St (L)Bathurst St, Pitt Town Rd to terminate at Schofields Rd (**Omitting Hall St & Pitt Town Bottoms Rd** due to nil patronage).

There are **no** additional changes to the directions of the service.

The service will operate as displayed below:

FIRST SET DOWN ANDREW THOMPSON DRIVE

School Bus 5522 departs **Bede Polding College** at **3:05pm**, **opposite Chisholm Catholic Primary School (3:06pm) & Windsor Public School (3:16pm)** then to Andrew Thompson Dr via Andrew Thompson Dr (R)Old Hawkesbury Rd (L)Plimsoll Rd (R)Wolseley Rd to **Arndell College (3:29pm)**, Oakville Rd (L)Ogden Rd to **Oakville Public School (3:38pm)**. Then via Ogden Rd (L)Smith Rd (R)Oakville Rd, Wolseley Rd (L)Plimsoll Rd (L)Old Hawkesbury Rd (R)Meares Rd (L)Andrew Thompson Dr (L)Balmain Rd (L)McGrath Rd (L)Old Hawkesbury Rd (R)Pitt Town Rd to Ivy Av (**3:54pm**). Then continues via Pitt Town Rd (R)Wolseley Rd, Oakville Rd (R)Broos Rd (L)Commercial Rd (L)Glenidol Rd (L)Stahls Rd (R)Smith Rd (L)Saunders Rd (R)Old Stock Route Rd (R)Scheyvill Rd Rd (L)Old Pitt Town Rd (R)Airstrip Rd (L)Pitt Town Dural Rd (L)Cattai Rd, Eldon St (R)Bathurst St (R)Bootles Ln (L)Bona Vista St (L)Johnston St (L)Bathurst St, Pitt Town Rd to Schofields Rd.(**4:23pm**)
